#### **HIGHWAY AND FACILITIES REPORT:**

An oral report by Robert Nogan from Highway and Facilities:

DuPage County has approved the Maple Avenue culvert replacement plans. They are meeting with the engineer to get bid documents finalized and to get a bid opening date set.

The department had a significant snow and ice event last week and worked late into the night and early the following morning.

Last year's three recycling events collected 48,500 pounds of electronics and 3,700 pounds of textiles. The weights have decreased, but our township still collects more than other townships.

Director Nogan has been working with Midwest Paving Equipment on purchasing a new 2023 Falcon 2-ton asphalt hot box trailer. The current unit is more than 10 years old and needs quite a bit of maintenance. It is used for repairing small potholes and patch jobs. Also, the department is working with Biggers Chevrolet fleet sales on the purchase of a new 2023 Silverado 1500 pick-up truck which will be replacing a 2015 truck with 100,000 miles on it.

The 2023 Brush Pick Up dates have been set: April 24th, June 12th, August 14th, and October 16th. This is the last year of a five-year contract with Kramer Tree. The department will be going out for another five year bid this summer.
