Director Nogan is working with a fleet truck dealer to trade in the current pick-up with over 100,000 miles and a Suburban that is no longer used and purchase a new pick-up with the proceeds. Also, the department will start to replace several other pick-up trucks in the near future.

The last electronic recycling event was October 1st and the last brush pick up is scheduled for the week of October 24th. Next year's schedule should be finalized in the next month or two.
