HIGHWAY DEPARTMENT REPORT:

Everything is ready for snow, the guys have been out practicing with the plows, to get used to the extra width on the front of the trucks. We ordered 300 ton of salt that will be delivered on Monday; hopefully, that will hold us until January.

Our IGA with DuPage County on mowing the right of way is 90% done, it was reviewed by the attorney and also the State's attorney. Now it is in front of our insurance company, TOIRMA, to see if they have any comments or anything that they do not like or want to make a recommendation.

Our Engineering Ordinance fee is on the agenda, any questions on that I will answer when it is time.

Paving, we have a preliminary estimate to do 12 streets this coming season, one street is Spring Valley. The engineer's estimate is \$600,000.00 but that is a guestimate.

84 Court, Army Trail, West of Gary; this street has not been touched in over 35 years. The total with everything including curbs and storm sewers, preliminary estimate is \$440,000.00. We really cannot afford to do any improvements, so what we are going to do is budget a little bit every year, and we are going to patch it to keep it somewhat safe, then when we get the fund together, we will then move forward and rebuild 84 Court.

We have a preliminary total of electronic recycling for the year (without November). We have collected 126 ton or 252,000 pounds.

We partnered with the Village of Roselle in September, we collected 33,000 pounds of electronics and what was different, was we could not check residency.

That is all I have to report.

Supervisor Hovde thanked the Highway Commissioner for his report.
