## WHO IS ELIGIBLE?

You may be eligible to receive assistance if your household's combined gross income is at or below the following 200% poverty level:

## LIHEAP - LOW INCOME HOME ENERGY ASSISTANCE PROGRAM

### APPLICATION DATES AND DEADLINES

**October 2, 2023 - August 15, 2024**

**October 2** - LIHEAP will begin accepting applications for Seniors, Disabled and Families with Children Under 6.

**November 1** - Disconnected households or households in danger of disconnection.

**December 1** - All eligible applicants.

- **Eligible households are determined by** household size, gross household income, geographical location, and type of energy source used.
- **An overdue bill or disconnect notice** *is not* required.
- **You do not have to own your home or pay your gas and/or electric bills directly** to be eligible for assistance.

### THE FOLLOWING INFORMATION IS REQUIRED TO APPLY:

- Proof of gross income for all household members for the 30 days prior to and including the date you apply
- Your most recent heat and/or electric bill(s)
- Social Security card/ ITIN for all household members
- If you rent, your lease
- Additional documentation may be required
