ORDINANCE NO. 19-03

BE IT ORDAINED by the Board of Trustees of Bloomingdale Township, DuPage County, Illinois as follows:

SECTION 1: hereby determine and declare that the sum ofThree million three hundred twenty
nine thousand five hundred twenty one & 05/100 Dollars (\$ 3,329,521.05) are hereby levied
upon all property subject to taxation within the Township as that property is assessed and
equalized, in order to meet and defray all the necessary expenses and liabilities of the Township
as required by statute or voted by the people in accordance with the law, for such purposes as:
