HIGHWAY AND FACILITIES REPORT:

An oral report by Robert Nogan from Highway and Facilities:

Director Nogan commented how unusual this winter season has been. From a brutal stretch in January to a quiet month of February. In the meantime, the highway crew has completed all mailbox repairs and are now working on potholes, shoulder stone and starting some plow damage repair.

The department has caught up on salt deliveries and the dome is 100 percent full and they have fulfilled the minimum obligation per the contract.

The newest plow/dump truck is progressing at Lindco. The truck was ordered back in 2022 and is expecting delivery this spring. The Director is working on the specs and design of a new truck and plans will be made to order it this spring/summer.

Director Nogan has been working with the representative from our Union 399 to secure CDL training at the Union 150 facility which would speed up the process and reduce the cost. He plans on sending the new hire to CDL training this spring and to upgrade the employees with B licenses to train for a A licenses which would allow them to pull a trailer.

Last year's three recycling events collected 42,508 pounds of electronics and 1,179 pounds of textiles. The weights have decreased from last year and each year that seems to be the trend.

The dates for recycling are April 20th, June 29th, and September 7th. Brush pick up dates have not been established yet. Typically, the township and the Village of Bloomingdale have similar dates which are set up by Kramer Tree Specialists, Inc.
