Robert Nogan, Director of Highways and Facilities issued the following report:

The brush pick up bid opening was held on November 1st. Kramer Tree Specialists were the lowest bidder. The contract will run for 5 years with an increase of 3%.

The Broker drainage project is 90% completed. The storm sewers have been installed, all driveways have been replaced and the final grading is done. The final step will be to place the dirt and seed which will be completed soon.

The Director inspected one of the new plow trucks, being built by Monroe in Joliet. This should be ready in about a month. The second truck being built by Lindco in Indiana. The second truck was delayed due to back ordered parts, but construction should start soon. All trucks have been modified for snow removal. The first load of salt was delivered, and the dome is near capacity. The liquid de-icer tanks are all filled with Beet Heet and brine. The township was able to help Wayne Township with nearly 8,000 gallons of brine that is made in house.
