HIGHWAY DEPARTMENT REPORT:

We had to place our order for salt for next winter. Once again, we are able to partner with DuPage County who was able to negotiate a good price with the supplier. This past winter, Bob Nogan kept records on everything related to the snow season. The crew went out 27 times; they plowed for 782 hours and worked 310 hours of overtime. We also gave Winfield Township 4,000 gallons of salt brine.

We started electronic recycling on April 11th and took in 15,000 pounds of electronics. We tried to check for residency, but there was a great deal of arguing, so we had to stop. The next recycling will be May 2, 2015.

I attended the monthly meeting of the Highway Commissioners and found out that the Governor reduced the amount of fuel tax money we will be receiving. I usually dedicate these funds to paving of the streets. There may have to be some adjustments.

There was a serious flooding issue on Pearl Avenue in Glen Ellyn Countryside. We had to rent 4 pumps and 400 feet of hose to redirect the water to Sidney Avenue. With the help from DuPage County, who sent over a special camera, we found that roots had grown in the tiles. The County then sent out a special truck that was able to cut the tree roots out for us.

Brush pick up notification has been sent out and the first one will be the week of May 4th.

I attended the Glen Ellyn Countryside Homeowners meeting. The meeting went very well. I was asked to write an article in their newsletter on property maintenance.
