HIGHWAY DEPARTMENT REPORT:

At the beginning of August Bob Nogan and myself attended the TOI Highway Commissioners Summer Seminar in Peoria. The main topic was drainage laws.

In the past 60 days we have replaced 38 driveway pipes and aprons. The list for next year is already full. We are now starting a list for 2017, if work is necessary.

The Abilene and Conestoga Estates drainage project is completed. DuPage County was able to help pay some of the cost of this project.

We will begin paving August 26, 2015. We still have one street left to do in Glen Ellyn Countryside, then we will be working on roads in unincorporated Medinah and Roselle. For crack sealing we have joined with other DuPage Townships to get a "group price."

Our first delivery of salt for the upcoming snow season will be in September.

I have been doing research on the traffic issues in Medinah in regard to Thorndale, Linden, Crest and Sycamore Avenues. I have received report from DuPage County and I will contact the spokesperson to share this information with them.

Supervisor Levato thanked the Highway Commissioner for his report. Supervisor Levato also shared with the board a letter that was received from a homeowner in an unincorporated area praising the Highway Department for their "fine service, professional workmanship, including great cleanup of debris."
