HIGHWAY DEPARTMENT REPORT:

Highway Commissioner Czernek mentioned that January was challenging as our average snowfall is usually 36.7 inches and we received 63.5 inches. He noted that this was the third snowiest winter ever recorded in history since 1918. We have also had more sub-zero temperature days than we usually do.

The Highway Department has 600 tons of salt left to date. We are hoping that this will last us through March and April. We are now getting ready to bid for salt for next year and are closely calculating our amounts. The Township is able to piggy-back on the DuPage County order to obtain better pricing.

Highway Commissioner Czernek explained how throughout this season he has been using different additives to the salt and has finally found a combination that is usable to -40 degrees.

They are looking into notifying homeowners about mailbox violations, before the next winter season. Hopefully this will eliminate the problem of mailboxes being taken down during snow plowing.

The brush pick up bid opening will be Friday, February 21. Once we have the provider, we will work on the mailing to notify the homeowners.

Highway Commissioner Czernek will be attending the Glen Ellyn Countryside Home Owner's meeting on Thursday, February 20, at their request.

Supervisor Levato thanked Highway Commissioner Czernek for his report and all the hard work the entire department has been doing during this difficult winter.
