He found a tree down across Temple in Medinah, he called on one of his crew and they were able to clear the obstruction. Upon further inspection of the township's unincorporated areas, he found another tree down in Nordic and it had electrical wires in it that were live. They barricaded it and Com Ed came out and took care of the issue.

The electronic recycling that was done on Saturday, November 9th collected 14,500 pounds of electronics. The upcoming electronic recycling on December 7th will be that last one for this year and until April of 2014.
