# **HIGHWAY DEPARTMENT REPORT:**

Highway Commissioner Czernek commented that they officially started plowing on Saturday, November 15<sup>th</sup>. The Highway Department used 60 tons of salt. Our supply of road salt is coming in very slowly. We have to date received 28 out of 40 loads. We should receive another 15 loads this week. DuPage County has said that they will borrow us salt if we are still short on receiving our order.

We will start making salt brine on Friday.

Commissioner Czernek commented that he recently attended the 41<sup>st</sup> anniversary of PESO, Pilipino Engineering Scientist Organization. Many awards and speeches were given. He was very honored to have been able to attend.

The Highway Commissioner noted that Bob Nogan and Bruno Barton went with him to attend a calibrating salt seminar. Commissioner Czernek and Bob Nogan are also going to be recertified in fuel pumps. Vicki is a Class 2 certification. This is very important, as it is inspected by the State.

The Highway Department personnel will be participating in the 25<sup>th</sup> Basket Brigade. This is a program run by DuPage County to deliver holiday food baskets that prepares departments in the event that the need arises in an emergency situation that medicine would need to be distributed in our Township.

The cost for recycling last month was \$1,450.00. Commissioner Czernek said that they would need to look at this program before spring. He was informed that there will be a price increase in December. DuPage County is checking with other vendors.

Commissioner Czernek was able to catch the person who has been dumping concrete on the edge of the lake on Spring Valley Drive. DuPage County went out and put a stop to it. The Highway Department may have to help move things off the road, the Army Corp of Engineers is working on solving the issue.
