**TAX LEVY ORDINANCE**  
**ROAD DISTRICT**  
**ORDINANCE NO. 20-08**

An ordinance levying taxes for all road purposes for Bloomingdale Township Road District, DuPage County, Illinois, for the tax year 2020, collectable in 2021.

BE IT ORDAINED by the Board of Trustees of Bloomingdale Township, DuPage County, Illinois as follows:

SECTION 1: That the Highway Commissioner of Bloomingdale Township Road District on December 2nd, 2020 does hereby determine and declare that the sum of Three million three hundred fifty thousand & xx/100 dollars (\$3,350,000.00)

are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

Road & Bridge Fund (including share directly to villages)

Special Hard Road Fund

Equipment & Building Fund

for the year 2020.

SECTION 2: That the amount levied for each object and purpose shall be as follows:

SECTION 4: That the Board of Trustees does hereby certify that the amount levied herein is necessary to be raised by taxation for road purposes for Bloomingdale Township Road District.

SECTION 5: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not effect the validity of the remaining portion of this ordinance.

SECTION 6: That this ordinance shall be in full force and effect after its adoption, as provided by law.
