TAX LEVY ORDINANCE

TOWNSHIP

ORDINANCE NO. 21-05

An ordinance levying taxes for all town purposes for Bloomingdale Township, DuPage County, Illinois, for the tax year 2021, collectable in 2022.

BE IT ORDAINED by the Board of Trustees of Bloomingdale Township, DuPage County, Illinois as follows:

SECTION 1: hereby determine and declare that the sum of Three million one hundred
fifty-five thousand & 00/100 Dollars (\$3,155,000.00) are hereby levied upon all property
subject to taxation within the Township as that property is assessed and
equalized, in order to meet and defray all the necessary expenses and liabilities of the Township
as required by statute or voted by the people in accordance with the law, for such purposes as:

General Town Fund

General Assistance Fund

Community Mental Health Fund

For the year 2021.

SECTION 2: That the amount levied for each object and purpose shall be as follows:

<u>COMMUNITY MENTAL HEALTH FUND:</u> REF: Community Mental Health Act (405 ILCS 20/4)	<u>\$ 750,000.00</u>
<u>GENERAL ASSISTANCE FUND:</u> REF: General Assistance Tax (60 ILCS 1/235-20)	<u>\$ 105,000.00</u>











SECTION 5: That this ordinance shall be in full force and effect after its adoption, as provided by law.
