

TAX LEVY ORDINANCE

TOWNSHIP

ORDINANCE NO. 23-06

An ordinance levying taxes for all town purposes, including those for road purposes, as previously levied under a separate taxing district, for Bloomingdale Township, DuPage County, Illinois, for the tax year 2023, collectable in 2024.

BE IT ORDAINED by the Board of Trustees of Bloomingdale Township, DuPage County, Illinois as follows:

SECTION 1: hereby determine and declare that the sum of Seven million two hundred  
twenty thousand & 00/100 Dollars (\$7,220,000.00) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

General Town Fund

Community Mental Health Fund

General Assistance Fund

Road & Bridge Fund (including share directly to villages)

Special Hard Road Fund

Equipment & Building Fund

For the year 2023.

SECTION 2: That the amount levied for each object and purpose shall be as follows:

SECTION 5: That this ordinance shall be in full force and effect after its adoption, as provided by law.
