

TAX LEVY ORDINANCE

ROAD DISTRICT

ORDINANCE NO. 12-08

An ordinance levying taxes for all road purposes for Bloomingdale Township Road District, DuPage County, Illinois, for the tax year 2012, collectable in 2013.

BE IT ORDAINED by the Board of Trustees of Bloomingdale Township, DuPage County, Illinois as follows:

SECTION 1: That the Highway Commissioner of Bloomingdale Township Road District on November 20th, 2012 does hereby determine and declare that the sum of Three million
four hundred fifty three thousand, one hundred & xx/100 dollars (\$3,453,100.00)
are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

Road & Bridge Fund

Equipment & Building Fund

Special Hard Road Fund

for the year 2012.
