An ordinance levying taxes for all road purposes for Bloomingdale Township Road District, DuPage County, Illinois, for the tax year 2017, collectable in 2018.

BE IT ORDAINED by the Board of Trustees of Bloomingdale Township, DuPage County, Illinois as follows:

SECTION 1: That the Highway Commissioner of Bloomingdale Township Road District on November 21st, 2017 does hereby determine and declare that the sum of Three million six hundred sixty three thousand, eight hundred & xx/100 dollars (\$3,663,800.00)

are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

Road & Bridge Fund (including share directly to villages)

Special Hard Road Fund

Equipment & Building Fund

for the year 2017.

SECTION 2: That the amount levied for each object and purpose shall be as follows:

GENERAL ROAD FUND:

1) Maintenance & Administration
REF: General Road & Bridge Tax (605 ILCS 5/6-501 5/6-504) 810,590.00

2) Villages' Share (collected directly by municipalities)
REF: General Road & Bridge Tax (605 ILCS 5/6-507) 663,210.00

Total General Road Fund \$1,473,800.00

SPECIAL HARD ROAD FUND:

REF: Special Hard Road Tax (605 ILCS 5/6-601)

\$2,089,400.00

EQUIPMENT & BUILDING FUND:

REF: Equipment & Building Tax (605 ILCS 5/6 508.1)

SECTION 4: That the Board of Trustees does hereby certify that the amount levied herein is necessary to be raised by taxation for road purposes for Bloomingdale Township Road District.

SECTION 5: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not effect the validity of the remaining portion of this ordinance.

SECTION 6: That this ordinance shall be in full force and effect after its adoption, as provided by law.




