**TAX LEVY ORDINANCE**  
**SPECIAL POLICE DISTRICT**  
**ORDINANCE NO. 16-07**

An ordinance levying taxes for police purposes for Bloomingdale Township, DuPage County, Illinois, for the tax year 2016, collectable in 2017.

BE IT ORDAINED by the Board of Trustees of Bloomingdale Township, DuPage, Illinois as follows:

SECTION 1: hereby determine and declare that the sum of One hundred fifteen  
thousand and 00/100 Dollars (\$115,000.00) are hereby levied  
upon all property subject to taxation within the Township as that property is assessed  
and equalized, in order to meet and defray all necessary expenses and liabilities of the  
Township as required by statute or voted by the people in accordance with the law, for  
such purposes as:

for the year 2016.

SECTION 2: That the amount levied for each object and purpose shall be as follows:

**SPECIAL POLICE DISTRICT:**

REF: Police protection by County  
(60 ILCS 1/30-155)

Amount Levied

\$115,000.00

SECTION 3: That the Town Clerk shall make and file with the County Clerk of said County of DuPage, on or before the last Tuesday of December, a duly certified copy of this ordinance.

SECTION 4: That the Board of Trustees does hereby certify that the amount levied herein is necessary to be raised by taxation for police purposes for the Bloomington Township Special Police District.

SECTION 5: That If any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not effect the validity of the remaining portion of this ordinance.

SECTION 6: That this ordinance shall be in full force and effect after its adoption, as provided by law.


