ORDINANCE NO. 14-05

An ordinance levying taxes for all town purposes for Bloomingdale Township, DuPage County, Illinois, for the tax year 2014, collectable in 2015.

BE IT ORDAINED by the Board of Trustees of Bloomingdale Township, DuPage County, Illinois as follows:

SECTION 1: hereby determine and declare that the sum of	Three million one hundred
