TAX LEVY ORDINANCE

TOWNSHIP

ORDINANCE NO. 17-05

An ordinance levying taxes for all town purposes for Bloomingdale Township, DuPage County, Illinois, for the tax year 2017, collectable in 2018.

BE IT ORDAINED by the Board of Trustees of Bloomingdale Township, DuPage County, Illinois as follows:

SECTION 1: hereby determine and declare that the sum of Three million four hundred sixteen thousand & 00/100 Dollars (\$ 3,416,000.00) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

General Town Fund

General Assistance Fund

Community Mental Health Fund

for the year 2017.

SECTION 2: That the amount levied for each object and purpose shall be as follows:
