**Public Comment:** Dawn Arimura, Bloomingdale Youth Services, discussed 3 programs that she felt were doing "a fabulous job" in the township. First was the Roselle Police Department. Dawn reported that Colleen has returned from maternity leave. On Feb 25, Colleen took it upon herself to organize a village wide food drive March 6<sup>th</sup>, to replenish our depleted food pantry supplies. Also, the new police department social worker Misty spent 4 hours with a township therapist and a child and was able to place the child in partial hospitalization. The Roselle Police dept made "my life easier", dealing with emergencies. Second was Pastor Dan Riemenschneider. Pastor Riemenschneider discussed the Advisory Form and Youth Mental Health Training. On February 16<sup>th</sup>, the Advisory Board was held at the Bloomingdale Youth Services facility with 9 area agencies attending. Also, the Youth Mental Health Training took place on March 18 – 23 and was attended by teachers, teachers' aides, and professionals in the community. This training was held at the Hope Center. Third, ABC and Mary Crick had taken all the adult cases that Bloomingdale Township "couldn't handle" allowing the township to focus on the students and schools. These programs are taking stress off of the Bloomingdale Township Youth Services.

Dan Riemenschneider: Discussed the two grants that he is overseeing. On May 19<sup>th</sup>, the Advisory Forum is sponsoring an event in which they have a goal of having 200 youths attend. The second Youth Mental Health Training on April 29. The second grant is for the Church Youth Mental Health Center.

Mike Murray discussed ACMHAI's convention tomorrow via Zoom. Mike also mentioned that he attended the swearing in of the Addison Mental Health Board members and how this will help provide more services for students.
