DuPage Pads- Erica W.

Requesting \$15,000 to support case management salary for community outreach.

Easter Seals DuPage & Fox Valley- Theresa F.

Requesting \$75,000 to continue their outpatient medical rehab services for the uninsured, underinsured, those with insurance limits, and high deductible.

Marco Parducci arrived at 7:02pm.

Easter Seals DuPage & Fox Valley- Theresa F.

Requesting \$40,000 to serve 175 families, focused mostly on pediatrics, in the behavioral health program for those that are uninsured, underinsured, those with insurance limits, and high deductibles.

Glenbard Early Childhood Collaborative -Jeanine W.

Requesting \$77,000 to continue to new program for children ages 3-5 for continued wrap around support for children and families. This funding will help support salaries, supervision, and translation services.

• Haymarket- Zachary K.

Requesting \$5,000 to help support operations for clients that are Bloomingdale Township residents to have continuum of care.

Inca Relief- David Z.

Requesting \$62,000 to help training in 2 different modalities for case managers, give more counseling services to individuals.

Little City- Eugene M.

Requesting \$3,450 to help provide integrated community support outings to residents. This will help the residents become more socially active and receive entertainment through the year.

Marklund Children's Home- Carrie S.

Requesting \$15,000 to provide services and medical supplies to residents that reside in the Philips Home.

- Public Comment: Tim Heneghan, Schaumburg Township Supervisor. Tim expressed his
 appreciation for the Mental Health Board to giving guidance on the beginning of the
 Schaumburg Mental Health Board that has just passed.
