- 1. Michael Murray, 154 S. Prospect, Roselle, IL. Mr. Murray wished to address the board regarding the April Fools 5K at lake Park HS on April 6<sup>th</sup>
- 2. Bob Tanner Greater Elgin Family Center spoke during public comment; Expalined how they are expanding services into Bloomindale Township, they have been around for 17 years and have delivered services to ~17,000 people. Have 72% spanish speakers on staff. They also use the medically assisted therapy for opioid abuse victims in 8 centers across the five collar counties. They will be asking for a grant in the next round.
- 3. Dianna Arano Ray Graham; Ms Arano is the Employment Director and gave an update on their activities regarding, Job Expiration classes, Job Preparedness focusing on issues such as dress, interviews, etc.
- 4. Rachel Tsen Lake Park High School; Wanted to talk about the upcoming "Stomp Out Stigma" and health resource fair fundraiser coming up with money raised going to NAMI DuPage. So far in 2019 they have made presentations on stigma discussions and recovery stories at LPHS, Glenbard North, Glenbard East and 2 middle schools.
- 5. Mary Crick About Behavioral Change; New office in Roselle, they deal with gambling additions and substance abuse. They want to open a "Drop-In" center for gay, lesbian and trans youth.
