#### **DuPage Pads**

Erica Whalen and Scott Auspgen gave the presentation

Dominick Lanzito asked where their facility was and how they verify when services are given to Bloomingdale Township residents? The facility is in Wheaton and they use the DuPage County HIMS system for client identification

Mike McGinn asked the if the speaker could remove her mask and who is served by them? Anyone who presents is given aid and approximately 50% present with substance abuse or mental health issues.

Marco Parducci asked how many children do they see? 226 kids in 117 families with an increase in the age group of 0 to 5 years of age.

Dominick Lanzito asked where the groups meet and if the places charge rent? They are trying to get space at St. Isador and St. Mathews churches as well as another space in Bloomingdale. They would plan on giving some money to the churches. The frequency of the meeting are once per week, at least and they would be pulling attendees from the Bloomingdale and Roselle area. Kim Cline asked how many are in each meeting? The ideal is ten. Dominick Lanzito asked if the rooms would accommodate that number in the age of COVID. Yes. Diana Eckert said she was happy to see a Latino based organization making a grant request. Marco Parducci asked if the meetings were open ended? Yes they are ongoing and when they have more than tem attendees they can start another group. David Rogers asked about the use of this grant money? The goal is to start two groups locally.

David Rogers asked about the 24 hour response time goal? There is no tracking as yet but the response time has improved. Dominick Lanzito asked about the use of the grant money and

would grant money be used for reimbursement of court appointed guardians? The money would be used for contract employees which would require some expenses like mileage. None of the money is used for direct employees or any reimbursement of court appointed guardians. Marco Parducci asked about the type of calls? Two thirds are psych evaluation calls including domestic disturbance and well being checks. David Rogers asked about call frequency reduction as a result of the grant? No official numbers due to difficulty of the system but strongly felt there is a positive result in call frequency to the same address. Kim Cline expressed her thanks for connecting to the local schools.
