Grant #3: Access Community Health Network – Discussion about how they use the awards to start a new program but then take on themselves going forward. Award request granted.

Grant #4: Access DuPage – Discussion of how this is specific to our township and it is more of a pay as you go process. Award request granted.

Grant #5: AMITA Health – Discussion about them making an effort with kids in the school face to face. Award request granted.

Grant #6: Bloomingdale/Glendale Heights Police Departments – Discussion about how due to COVID people are turning to police more and the calls are up for domestic disturbances, etc. Award request granted.

Grant #7: Bloomingdale Township – Discussion of how a deployment of resources analysis would be helpful going forward. Award request granted.

Grant #8: Bloomingdale Township Youth Services – Discussion of benefits of this organization. Award request granted.

Grant #9: DuPage Pads – Discussion of how this could be needed more when the ban on evictions is lifted. Award request granted.

Grant #10 & #11: Easter Seals DuPage & Fox Valley – Discussion of how early intervention is important and collaboration with the YMCA. Award request pro-rated.

Grant #12: Grow Illinois – Discussion concerning the township residency and if this is service is already available. Also the award requested is small. Award request granted.

Grant #18: NAMI of DuPage County – Discussions regarding the concerns about the salary allocations at the director level and focus on Bloomingdale Township. Award request partially granted.

Grant #19: Ray Graham Association for People with Disabilities – Discussion about how the presentation was very good. Award request partially granted.

Grant #20: Teen Parent Connection – Discussion about how we would like to see more focus on prevention, the early start intervention is important. Award request partially granted.

Grant #21: Village of Roselle Police Department – Discussion of other services available for Officer therapy rather than use grant money for this activity. There was a call reduction in repeat calls attributed to this function. Award request partially granted.

Grant #22: YWCA Metropolitan Chicago – Discussion about how early detection is critical and useful. Award request partially granted.
